06-16-25 Update from Jeanne: I have heard from Attorney Paul Hinkley, our HOA lawyer. He received a response from the tenants at 1569 Victoria Way. They sent a letter to him explaining that they are not renting, but they are friends of the family. However, they also stated that they understand HOA policy and have asked for 60 days to find another living arrangement and move out their items. Our CC&R's state "owner occupied only" which means no tenants, paying or not paying rent. Paul suggests we grant them the 60 days to move because if this case went to court, the courts would grant them the time. I said that we will go with his legal advice. He will draft a letter in the next few days to them stating our position. So, it appears that they will be moving out.
